## Export Container Detention Adjustment

Dear Valued Customers,

Please note that effective from 1<sup>st</sup> August 2022, our Export Container Detention tariff rate will be adjusted to the following.

PIL grant **14** free days export detention on all export GP/HC and **10** free days for RF/HR/FR/OT containers. These free days are calculated from and are inclusive of, the date the empty container is picked up from the depot, until the date the container is returned back full to the terminal for export.

20 GP	AUD <b>\$75.00/day</b>	From 15th day onwards
20 OT - 20' Open Top	AUD <b>\$150.00/day</b>	From 11th day onwards
20 FR - 20' Flat Rack	AUD <b>\$150.00/day</b>	From 11th day onwards
20RH	AUD <b>\$150.00/day</b>	From 11th day onwards
40 GP / HC	AUD <b>\$150.00/day</b>	From 15th day onwards
40 OT - 40' Open Top	AUD <b>\$300.00/day</b>	From 11th day onwards
40 FR - 40' Flat Rack	AUD <b>\$300.00/day</b>	From 11th day onwards
40 RH	AUD <b>\$300.00/day</b>	From 11th day onwards

**N.B. Containers not shipped and returned to the depot will be subject to LOLO charges and export detention will be charged from day of empty pick up until the day of empty return (with no free time).**
